The Board met in session at the Linn County Jean Oxley Public Service Center. Present: Chairperson Running-Marquardt, Vice Chairperson Rogers and Supervisor Zumbach. Board members voting "AYE" unless otherwise noted.

Chairperson Running-Marquardt called the meeting to order.

Motion by Rogers, seconded by Zumbach to approve minutes of September 4, 2024 as printed.

Chairperson Running-Marquardt read the Latino Festival Day, Sept. 14, 2024 Proclamation.

Motion by Running-Marquardt, seconded by Rogers to approve Proclamation: Latino Festival Day, Sept. 14, 2024.

Will Wright, Juvenile Detention & Diversion Services Dir., presented the PREA Improvement Project grant between Linn County Juvenile Detention and Iowa Department of Human Services in the amount of \$5,115.50. The Board will approve on Wednesday.

Sonia Evans, Finance & Budget, presented the reallocation of American Rescue Plan Act funds from Linn County department projects. She listed the departments that have turned back funds not used as well as departments that wish to have their funds rolled back.

Supervisor Zumbach explained that these Federal funds must be obligated in 2024 and spent by 2026.

Darrin Gage, Dir. of Policy & Admin., presented his recommendations for reallocations to the following county projects: Correctional Center Isolation Cell proj.; Homeless Shelter (elevator shaft & car); Hwy. 13 property renovation; and water main extension from Marion to Co. Home Rd.
