The Board met in session at the Linn County Jean Oxley Public Service Center. Present: Chairperson Running-Marquardt, Vice Chairperson Scheetz, and Supervisor Meisheid. Board members voting "AYE" unless otherwise noted.

Chairperson Running-Marquardt called the meeting to order.

This is to save money versus doing a large-scale clearing job every couple of years that costs around \$20,000 each time. Maintenance will now be 3-4 times a year at \$300.83 per visit out of Facilities' budget. Finance & Budget has approved.
